

2012-2013

1. Introduction

The National Arts Centre (NAC) is pleased to provide its fifth annual report on the administration of the *Access to Information Act* (ATIA) for the fiscal year 2012-2013, as required by section 72 of the Act.

The ATIA is based on the following principles:

- government information should be made available to Canadians and permanent residents of Canada;
- exceptions to the right of access should be limited and specific, and;
- decisions on the disclosure of government information should be reviewed independently of government.

2. Mandate

The National Arts Centre Corporation was established in 1966 pursuant to the *National Arts Centre Act* and began operating the Centre in 1969. The NAC reports to Parliament through the Minister of Canadian Heritage.

The NAC is a federal cultural organization dedicated primarily to developing and showcasing the performing arts in the National Capital Region and across Canada. It is a multidisciplinary performing arts centre that features classical music, dance, English and French language theatre, regional programming, special events and variety shows. The NAC takes part in co-productions with other organizations throughout the country, hosts festivals, and, through its new technologies and international tours, reaches out to audiences across Canada and around the world. It is at the forefront of youth and educational activities, supporting programmes for young and emerging artists and programmes for young audiences and producing resources and study materials for teachers.

In furtherance of its objectives to operate and maintain the Centre, the Corporation may arrange for and sponsor performing arts activities at the centre; encourage and assist in the development of performing arts companies resident at the Centre; arrange for or sponsor radio and television broadcasts and the screening of films in the Centre; provide accommodation at the Centre, on such terms and conditions as the Corporation may fix, for national and local organizations whose objectives include the development and encouragement of the performing arts in Canada; and, at the request of the Government of Canada or the Canada Council for the Arts, arrange for performances elsewhere in Canada by performing arts companies, whether resident or non-resident in Canada, and arrange for performances outside Canada by performing arts companies resident in Canada.

The Corporation is deemed, under Section 15 of the *National Arts Centre Act*, to be a registered charity within the meaning of that expression in the *Income Tax Act*.

3. Institution and Delegation Order

The NAC is presided by a Board of Trustees consisting of eight members from across Canada who are appointed by the Governor in Council and two ex-officio members. It has the authority to appoint a President of the Centre, who is Chief Executive Officer, responsible for the operation and administration of the Corporation and its Centre.

The NAC's Access to Information and Privacy (ATIP) Office consists of one ATIP Coordinator on a contract basis.

Pursuant to Section 73 of the ATIA, delegated authority has been designated to the person holding the position of ATIP Coordinator, to exercise or perform all powers, duties and functions of the CEO and President under the Act insofar as they may be exercised or performed in relation to the NAC.

4. Summary of the NAC's access to information activities during the fiscal year 2012-2013

The NAC received four access to information requests and two additional requests carried over from the previous year. All requests were completed during this fiscal year and none were carried forward.

The statistical report for the period April 1, 2012 to March 31, 2013 is appended.

Interpretation of the statistical report

During this fiscal period, the NAC processed one request from academia, two requests from an organization and two requests from the media. One of the two requests outstanding from the previous fiscal period was also received from the media, while the other came from an organization.

Disposition of the requests

Of the four access to information requests received and completed during this reporting period, information was all disclosed for two requests; information was disclosed in part for one request; and information was all exempted for one request. For the two requests outstanding from the previous fiscal period, information was disclosed in part for one, and all disclosed for the other.

All six requests were processed and completed within the 30 day statutory limit.

5. Education and Training

A bulletin was sent to all National Arts Centre staff on January 28, 2013, as part of "Data Privacy Day", designated by the Office of the Privacy Commissioner of Canada. The bulletin included the NAC's Information Management Policy and encouraged employees to review the files in their office or on their computer and dispose of any transitory records they might have.

No other access to information-related training took place during the 2012-2013 fiscal period.

6. Administration of the Access to Information Act

In May 2012, the National Arts Centre began posting monthly summaries of all Access to Information requests on its website. The move was part of the NAC's ongoing commitment to transparency and accountability in the administration of its Access to Information program.

On January 31, 2013, Treasury Board Secretariat issued a Standard on Privacy and Web Analytics requiring Government of Canada

departments, agencies and Crown Corporations (including the National Arts Centre) to meet specific requirements limiting the use of Web analytics. The NAC was in full compliance with the new requirements before the Standard went into effect.

There were no other events of note affecting the Office of the NAC ATIP Coordinator in the last year.

7. Complaints, Investigations and Reviews to the Federal Court

No complaints were lodged with the Office of the Information Commissioner of Canada during this fiscal period. There are currently no outstanding complaints. There were no appeals or reviews made to the Federal Court for the 2012-2013 fiscal year.

The National Arts Centre (NAC) is pleased to provide its annual report on the administration of the *Privacy Act* for the fiscal year 2012-2013, as required by section 72 of the Act.

The *Privacy Act* protects the privacy of individuals with respect to personal information about themselves held by the NAC. The Act recognizes that the right to privacy entails the right to control the use and disclosure of information about oneself.

There was one event of note that affected the Office of the NAC ATIP Coordinator in the last year: on January 31, 2013, Treasury Board Secretariat issued a Standard on Privacy and Web Analytics requiring Government of Canada departments, agencies and Crown Corporations (including the National Arts Centre) to meet specific requirements limiting the use of Web analytics. The NAC was in full compliance with the new requirements before the Standard went into effect.

5. Information on Privacy Impacts Assessments (PIA)
